UPPCO's operations plan is to follow the requirements outlined in Articles 402 (Water Surface Target Elevations) and Article 403 (Minimum flows). As such, below are the elevation targets:

UPPCO will adjust outflows from the respective facilities to best achieve the target elevation for the current/upcoming month.

Based on current elevations of the Silver Lake Storage Basin and the Dead River Storage Basin (Hoist) in respect to the June/July target elevations, Maximum flow releases through the Hoist facility will continue until elevations approach the target elevation. Once the Dead River Storage Basin elevations near the target elevation, outflows from the Silver Lake storage basin will be increased to trend that storage basin towards its required target elevations. Outflows from the Silver Lake facility will not exceed 150 cfs per the conditions outlined in article 403, and elevations at both the Silver Lake Storage Basin and Dead River Storage Basin (Hoist) will not be lowered more than 0.5' per day based on article 402.

There are no 'scheduled' releases from the Silver Lake Storage Basin outside of the headwater elevation reductions required between July/August and August/September.
